<p>STATUTES</p> <p>Article1 - Name and Head Office</p> <p>1.1 The international association resulting from the conference organized by UNESCO in Edinburgh in 1955 is named Centre international du film pour l'enfance et la jeunesse (abbreviated as CIFEJ) and International Centre of Films for Children and Young People.</p>	
<p>1.2 The Head Office is established in Montreal, Canada. It can be transferred by a simple decision of the board of directors, to be ratified by the next general assembly.</p>	<p>1.2 The Head Office is established in Tehran, Iran. It can be transferred by a simple decision of the board of directors, to be ratified by the next general assembly.<i>(Gunther Kinstler)</i></p>
	<p>1.2 The location of the Head Office is determined by the board of directors and is endorsed by the general assembly. <i>(Mohsen Chiniforoushan)</i></p>

<p>Article 2 - Objectives</p> <p>2.1 Founded with the encouragement and financial aid of UNESCO, CIFEJ subscribes to the fundamental principals of this intergovernmental institution, an agency of the United Nations. Consequently, it aspires to actively contribute to reaching the humanitarian aims of UNESCO in education, in science and in culture throughout the world (understanding between nations; respect of the Rights of Man and the Child; racial, linguistic and religious tolerance) by audio-visual means, and through cultural diversity.</p>	
<p>2.2 Its goals, and the means to achieve them, are described in greater detail in the following:</p>	
<p>2.2.1 To promote and encourage the production and dissemination of films, from various countries, and especially designed for children or suitable for them, with the following objectives: entertainment, art, information, and education.</p>	<p>2.2.1 To promote and encourage the production and dissemination of films, from various countries, and especially designed for children and young people or suitable for them, with the following objectives: entertainment, art, information, and education. (Mohsen Chiniforoushan)</p>
<p>2.2.2 To coordinate action, both on the international level and within various countries, promoting the unimpeded circulation and exhibition of films suitable for a young audience, as well as of those made by children.</p>	
<p>2.2.3 To collect, exchange and disseminate information concerning:</p> <p>a) the world-wide production, distribution and exhibition of such films, via the periodical publication of lists of films (cinema, television, video) selected for children and young people in different countries, and a directory of producers and distributors of children's films and programs;</p>	

<p>b) research about the influence of these films on children and young people, and about the tastes of children and young people;</p> <p>c) current legislation in force in different countries, notably with regard to the protection and education of children and young people in the sphere of audio-visual media;</p>	
<p>2.2.4 To promote and coordinate all studies and investigations with regard to the cinema and television for youth.</p>	
<p>2.2.5 To aid the development of children's and young people's education in the audio-visual language of the cinema and television, both in and out of school.</p>	
<p>2.2.6 To find and encourage all those who might be associated with such an effort to undertake the initiation of children to the techniques and art of the audio-visual media.</p>	
<p>2.2.7 To encourage the versioning in various languages of those films which promote international understanding and co-operation among young people, and cultural diversity.</p>	
<p>2.2.8 To promote the production, the distribution, and exchange of films made by children and young people.</p>	
<p>2.2.9 To coordinate the contacts and exchanges between the various organizations and persons who are working to achieve the above goals.</p>	
<p>Article 3 - Members and conditions of admission</p> <p>3.1 An individual or corporate body that upholds the objectives of CIFEJ and that is active in the area of audio-visual media for children and young people may become a member. CIFEJ also nominates honorary members and welcomes Friends of CIFEJ.</p>	

<p>3.2 Members.</p> <p>3.2.1 Members may be associations, foundations, organizations, incorporations, agencies, companies or individuals that are active in audio-visual media relating to children and young people.</p>	<p>3-2-1 Members may be associations, foundations, organizations, incorporations, agencies, companies, festivals, or individuals that are active in audio-visual media related to children and young people. (Mohsen Chiniforoushan)</p>
<p>3.2.2. The application for admission must be addressed to the board of directors by way of the secretariat. It must be accompanied, if necessary, by:</p> <p>a) a copy of the statutes or of the incorporation of the association-candidate;</p>	
<p>b) a list of the associations, or the people, regrouped by the association-candidate, with some indication of the principal role or employment held outside of association;</p>	
<p>c) a list of the board members of the association, with some indication of their responsibilities.</p>	
<p>d) a report of activities in the field of audio-visual media for children and young people.</p>	
<p>3.2.3. The application is reviewed by the admission committee whose recommendation confers membership status on the candidate.</p>	<p>3.2.3 The application is reviewed by the board of directors by simple majority and confers membership status on the candidate. (Gunther Kinstler)</p> <p>3.2.3 The application is reviewed and could be confirmed by the admission committee. (rest of the paragraph to be deleted). (Mohsen Chiniforoushan)</p>
<p>3.2.4. If not admitted, the candidate may request, by registered letter addressed to the president, a review of the application at the next general assembly.</p>	
<p>3.2.5. A member is considered “national” or “international.” International organizations are those with members in a variety of countries.</p>	

<p>3.2.6 Members pay annual dues at a rate assessed by the board of directors and ratified by the general assembly.</p>	
<p>3.2.7 Members take on the following responsibilities:</p> <p>a) to do everything possible to make the goals and activities of CIFEJ known, to arouse maximum interest in them, to stimulate and coordinate useful actions to this effect in the various countries;</p>	
<p>b) to advise the secretariat of any actions or events of an international or national nature which might have any interest for CIFEJ;</p>	
<p>c) to keep the Secretariat informed of the member's activities on a regular basis;</p>	
<p>d) to pay the dues required.</p> <p>3.3 Honorary members. 3.3.1 Following the suggestion of the board of directors, the general assembly may confer the title of honorary member on persons who have rendered distinguished service to CIFEJ. 3.3.2 Honorary members need not pay dues but will receive all regular CIFEJ publications.</p>	
<p>3.3.3 They may attend general assemblies in a consultative role, and all other non-administrative meetings organized by CIFEJ, or involving its collaboration or patronage. They have no right to vote.</p>	
<p>3.3.4 If, on the other hand, an honorary member wishes to pay dues, he will have the right to vote.</p>	
<p>3.4 Friends of CIFEJ. 3.4.1 A corporate body or individual person interested by CIFEJ's work may become a Patron of CIFEJ by making a voluntary contribution.</p>	

<p>3.4.2 Friends of CIFEJ do not receive regular CIFEJ publications.</p>	
<p>3.4.3 They may attend general assemblies in a consultative role, and all other non administrative meetings organized by CIFEJ. They have no right to vote.</p>	
<p>Article 4 - Resignation, cancellation, expulsion 4.1 The qualification as member is lost by resignation, cancellation or expulsion.</p>	
<p>4.2 Resignation must be sent by way of the secretariat to the board, which will notify the next ordinary general assembly.</p>	
<p>4.3 The executive director may propose to the board that a member is considered "inactive" after notification of the interested member in cases where the member has ceased to pay its dues.</p>	
<p>4.4. The executive director may propose to the board the cancellation of a membership after notifying the interested member in cases where the member has ceased to pay his dues for one year and ceased to communicate with the secretariat. If there has been no concrete action by the member after 12 months, the membership may be canceled, and the board will notify the next ordinary assembly of its decision.</p>	
<p>4.5 The board of directors may decide the expulsion of a member after notification of the interested member in cases where the attitude or the conduct of the member may gravely prejudice the aims and interest of CIFEJ. Expulsion of a member shall be ratified by two-thirds of the members present or represented at the next general assembly; abstentions and spoiled ballots will be disregarded.</p>	

<p>4.6 A member who has resigned or been expelled, or whose membership has been cancelled, has no financial right concerning CIFEJ and may not claim repayment of the dues already paid.</p>	
<p>Article 5 – Resources 5.1 The resources of CIFEJ consist of the dues paid annually by members, the revenues from cultural events or other events; and public or private grants, revenues from publications and advertising, bequests and gifts authorized by law.</p>	
<p>Article 6 - Structures 6.1 The governing bodies of CIFEJ are the general assemblies, the board of directors, and the executive committee.</p>	
<p>6.2 The administrative and coordinating body is the secretariat.</p>	
<p>6.3 Furthermore, specialized working groups can be formed by the governing bodies to carry out certain tasks.</p>	
<p>6.4 Regional CIFEJ offices and liaison offices may be established. The purpose of these offices is to organize the work of CIFEJ members in a given region, and to facilitate the contacts between the region and the secretariat. The creation and location of these offices, as well as their mode of operation, is decided by the Board of Directors, and ratified at the next General Assembly.</p>	
<p>Article 7 - General Assemblies 7.1 An ordinary general assembly will be convened every two years, eventually alternating with regional meetings.</p>	<p>7.1 An ordinary general assembly will be convened every three years, eventually alternating with regional meetings. (Athina Rikaki)</p> <p>(To be added :) 7-1-1 A General Assembly can be convened only by a quorum of half +1 of the voting members, present or represented. (Mohsen Chiniforoushan)</p>

<p>7.2 Each member whose dues are paid in full has the right to vote. The principal “one nation, one vote” will be maintained as outlined in the bylaws.</p>	
<p>7.3 If a member is unable to be present at the general assembly, this member may be represented by another member by submitting, through the secretariat, a general or a specific proxy in writing.</p>	<p>7.3 If a member is unable to be present at the general assembly, this member may be represented by another member by submitting, through the secretariat, (To be added :) one month before the general assembly a specific proxy in writing. (Athina Rikaki)</p>
	<p>(To be added :) 7-3-1 Each member can be the representative of at most 7 other members who are not able to be present at the general assembly. (Mohsen Chiniforoushan)</p>
	<p>(To be added :) 7-3-2 The conditions for proxies will be decided by the board of directors. (Mohsen Chiniforoushan)</p>
<p>7.4 The executive director proposes the agenda which is approved by the board of directors, and accepted by the general assembly by a vote of two-thirds of the members present or represented, abstentions and spoiled ballots disregarded. Once the agenda has been approved, no new items may be added.</p>	
<p>7.5 By simple majority, the general assembly designates two scrutineers to verify the votes.</p>	
<p>7.6 The ordinary general assembly elects the members of the board by secret ballot.</p>	
<p>7.7 It elects auditors to verify the financial accounts.</p>	
<p>7.8 The general assembly receives the financial report covering the period since the last general assembly, approves it, and also approves the budget for the coming period.</p>	

<p>7.9 General assemblies are called four months in advance, at the time and place approved by the board of directors. A draft agenda will accompany the notice.</p>	
<p>7.10 An extraordinary general assembly may be convened with two months notice at the request of at least one-third of the members whose dues are up-to-date or by the board of directors.</p>	
<p>7.10.1 The extraordinary general assembly can only deal with the matters for which it has been convened.</p>	
<p>7.10.2 It votes by simple majority of the members present or represented, abstentions and spoiled ballots disregarded.</p>	
<p>Article 8 - The board of directors and the executive committee</p> <p>8.1 There are nine members on the board of directors.</p>	<p>8.1 There are eight members in total on the board of directors(Mohsen Chiniforoushan)</p> <p>8.1 There are six members on the board of directors. (Günther Kinstler)</p>
<p>8.2 Candidates for election as director must meet the requirements as set out in the bylaws. Once elected, each director serves as an individual.</p>	

<p>8.3 Eight directors are elected by secret ballot by the members as set out in the bylaws. These directors serve for a term of two years. They cannot serve for more than two consecutive terms. Half of the board is eligible for re-election to its second term every two years. In addition, two substitutes are elected in case a position on the board becomes vacant before the next general assembly at which there is a statutory election.</p>	<p>8.3 Six directors are elected by secret ballot by the members as set out in the bylaws after the election of the president. (Mohsen Chiniforoushan)</p>
	<p>8.3 Five directors are elected by secret ballot by the members as set out in the bylaws. These directors serve for a term of 2 years. They cannot serve for more than three consecutive terms. (To be deleted: Half of the board is eligible for re-election to its second term every two years.) In addition, two substitutes are elected in case a position on the board becomes vacant before the next general assembly at which there is a statutory election. (Günther Kinstler)</p>
	<p>8.3 Eight directors are elected by secret ballot by the members as set out in the bylaws. These directors serve for a term of three years. They cannot serve for more than two consecutive terms. (Athina Rikaki)</p>
	<p>8.3 Eight directors are elected by secret ballot by the members as set out in the bylaws. These directors serve for a term of Four years. They cannot serve for more than two consecutive terms. (Samir Nasr)</p>
<p>8.4 The ninth member of the board, the Secretary general, is elected by the members in the country which houses the secretariat; the choice is ratified by the general assembly.</p>	<p>8.4 The sixth member of the board, the secretary general, is elected by the members in the country, which houses the secretariat; the choice is ratified by the general assembly. (Günther Kinstler)</p>
	<p>8.4 The 8th member, the secretary general, is elected by the members in the country which houses the secretariat; the choice is ratified by the general assembly. (Mohsen Chiniforoushan)</p>

<p>8.5 From its members, the board of directors elects a first vice-president and a second vice-president. All responsibilities are conferred on the officers for two years, renewable until the end of their term as director.</p>	
<p>8.6 The board of directors meets as often as the work of CIFEJ requires. It is entitled to make any decisions and to take any initiatives necessary.</p>	
<p>8.7 Board meetings require a quorum of five directors. All directors on the board have the right to vote.</p>	<p>8.7 Board meetings require a quorum of four directors. All directors on the board have the right to vote. (Günther Kinstler)</p>
<p>8.8 In years in which there is no general assembly, the board receives the financial report covering the period since the last general assembly, votes a provisional approval, and also approves the budget for the next year.</p>	
<p>8.9The board may delegate the management of current operations to an executive committee, constituted according to the bylaws.</p>	
<p>8.10 The board of directors or the executive committee may consult with representatives of the members or of the working groups, as the agenda requires. They may also call upon one or several representatives of UNESCO and other experts concerning items on the agenda.</p>	
<p>8.11 Decisions of the board and the executive committee are taken by simple majority of the directors present; if there is a tie, the president's vote is decisive.</p>	
<p>8.12 If, for good cause, the statutory general assembly cannot be held as planned, the board of directors, under exceptional circumstances, may make urgent decisions otherwise reserved for the general assembly.</p>	
<p>Article 9 – Presidency 9.1 The president of CIFEJ is elected directly by a simple majority of the general assembly prior to the election of other members of the board of directors.</p>	
<p>9.2 The president is elected for two years; he/she may be re-elected twice.</p>	<p>9.2 The president is elected for three years; s/he may be re-elected twice.(Athina Rikaki)</p>

<p>9.3 The president votes at the executive committee, at board meetings and during the general assemblies.</p>	
<p>9.4 The president represents CIFEJ during legal proceedings and in all civil affairs. He/she may delegate his/her authority, in whole or in part, to the Secretary general.</p>	
<p>9.5 If, extraordinarily, the president is unable to delegate his/her authority and the two vice-presidents are each unable to act, the duties of the president will be assumed, temporarily, by a board member chosen by the board, until the next general assembly.</p>	
<p>9.6 The president or, in his/her absence, one of the vice-presidents, presides over the general assemblies and the board meetings, as well as over the executive committee meetings. If both the president and the vice-presidents are absent, the secretary-general will direct the debates.</p>	
<p>Article 10 - Secretariat 10.1 The offices of CIFEJ are located at the headquarters and are managed by the secretariat. It is responsible for the administrative and financial tasks, and executes the policies and decisions of the general assembly and the board of directors.</p>	<p>Article 10 - Headquarters 10.1 The Headquarters is responsible for the Secretariat, administrative and financial tasks, and executes the policies and decisions of the general assembly. The Headquarters supervises the regional offices. (Mohsen Chiniforoushan)</p>
	<p>10.1 The offices of CIFEJ are located at the headquarters. (To be deleted: and are managed by the secretariat). It is responsible for the administrative and financial tasks, and executes the policies and decisions of the general assembly and the board of directors.(Günther Kinstler)</p>
<p>10.2 The board of directors appoints a treasurer residing in the country where the Secretariat is based, for a period of two years. This appointment is ratified by the general assembly. The treasurer works on a voluntary basis.</p>	<p>10.2 The board of directors appoints a treasurer residing in the country where the Headquarters is based. (To be deleted: for a period of two years. This appointment is ratified by the general assembly.) The treasurer works on a voluntary basis. (Günther Kinstler)</p>

10.2.1 The treasurer attends board meetings in a consultative capacity.	
	(To be added :) 10.2.2 The CIFEJ account is in the country of the secretariat and the account holder is CIFEJ. The account cannot be personal. (Eszter Voojala)
10.3 The executive director is an employee of CIFEJ, hired by the executive committee upon recommendation of the president.	
10.3.1 His/her term is for two years, and may be renewed; he/she may be dismissed for cause.	
10.3.2 He/she attends board meetings in a consultative capacity.	
Article 11- Modification of Statutes 11.1 The statutes can only be modified by an extraordinary general assembly requested by board of directors.	
11.1.1 If two-thirds of the voting members are not present or represented at this first meeting, a second extraordinary general assembly will be convened in conjunction with the next ordinary general assembly and the convocations should be sent out conjointly.	
11.1.2 This assembly is authorized to modify the statutes, by a majority of two-thirds of the votes, disregarding spoiled ballots and abstentions, and in conformity with the stipulations of article 7, regardless of the number of members present.	
11.2 In the case of a modification proposed by one active member, the board of directors must be notified by registered letter three months before the extraordinary general assembly.	
11.3 Two months before the extraordinary general assembly, the board of directors must bring the old texts and new proposed text to the attention of the members.	
11.4 The statutes become effective upon adoption.	

11.5 The bylaws may be modified by a simple majority at an ordinary general assembly and must, at all times, conform to the statutes.	
Article 12 - Dissolution 12.1 The decision to dissolve CIFEJ must be taken at an extraordinary general assembly, which has a quorum of two-thirds of the members, present or represented, convened to deal with the matter.	
12.1.1 For a proposal on dissolution to be accepted, it must be passed by a majority of two-thirds of the votes by members present or represented, disregarding spoiled ballots and abstentions, and in conformity with the stipulations of article 7.	
12.2 If two-thirds of the voting members are not present or represented at this meeting, a second extraordinary general assembly will be convened within three months.	
12.2.1 This meeting is authorized to decide by a majority of two-thirds of the votes, disregarding spoiled ballots and abstentions, and in conformity with the stipulations of article 7, regardless of the number of members present or represented.	
12.3 The extraordinary general assembly, which decides on the dissolution will appoint one or several liquidators and will determine the manner in which the assets of CIFEJ will be distributed, in accordance with the legal requirements.	
BYLAWS I. Admission into CIFEJ	

<p>1.1 All new applications for admission as a member of CIFEJ will be submitted to an admissions committee.</p>	<p>1.1 All new applications for admission as a member of CIFEJ will be submitted to the board of directors that confers membership status on the candidate. (Günther Kinstler)</p>
	<p>1.1 All new applications for admission as a member of CIFEJ will be submitted to the Headquarters. (Mohsen Chiniforoushan)</p>
<p>1.2 This committee is made up of three members: the president, the executive director and a member from the same country as the candidate. In the case where there are no previous members in a country, the third member of the committee will be the secretary-general.</p>	<p>1.2 (the paragraph to be deleted:) (Günther Kinstler)</p>
	<p>1.2 The admission committee is made up of three members: the president, the secretary general, and the executive director. (Mohsen Chiniforoushan)</p>
<p>1.3 In no instance may all three members of the committee come from the same country.</p>	<p>1.3 (the paragraph to be deleted :) (Günther Kinstler)</p>
	<p>1.3 In no instance may all three members of the committee come from the same country. (To be added :) In case all the three members of this committee are from the same country, one of the vice-presidents will substitute the president. (Mohsen Chiniforoushan)</p>

<p>II. General assembly</p> <p>2.1 Notification: the date of the notification will be that of the postmark or the fax activity report, or the e-mail activity report.</p>	
<p>2.2 Agenda:</p> <p>2.2.1 Notification of meetings of ordinary general assemblies will be sent to all members four months in advance, and suggestions will be solicited.</p>	
<p>2.2.2 Any member may ask the secretariat to include an item in the agenda, providing it is done three months prior to the general assembly.</p>	
<p>2.3 Votes:</p> <p>2.3.1 The right to vote of each member is exercised either individually by the member, or collectively by all members of a same country, or by members who form a group to vote together.</p>	
<p>2.3.2 In each country, the number of votes corresponds to the number of members in the country which has the most members; each country has the same number of votes.</p>	
<p>2.3.3 This figure (the number of votes by country) will be announced by the secretariat at the opening of each assembly.</p>	
<p>2.3.4 Therefore, the vote held by each member corresponds to the following formula: the number of members in the country with the most members, divided by the number of members in the member's country, rounded off to the first decimal point.</p>	
<p>2.3.5 Each member with international status has the same number of votes as an individual country.</p>	
<p>2.4 Observers:</p> <p>2.4.1 In addition to their official delegates, members may send observers to the general assembly.</p>	
<p>2.4.2 At the discretion of the board of directors, other observers may be invited.</p>	
<p>2.4.3 They do not have the right to vote but the president of the assembly may invite them to take part in the debates.</p>	

<p>III. The board of directors</p> <p>3.1 Candidates to the board of directors, including the president, are nominated from among the members by the members.</p>	
<p>3.1.1 The names of candidates must be sent to the secretariat prior to two months before the date of the next general assembly.</p>	
<p>3.1.2 The secretariat is responsible for verifying the qualifications of the candidates and informing the board of directors.</p>	
<p>3.2 If the number of candidates is inadequate to meet the requirements of the statutes, the board will suggest additional candidates from among the willing delegates present at the general assembly.</p>	
<p>3.2.1 The nomination of a candidate implies that he/she accepts the financial conditions of participating in events.</p>	
<p>3.3 Regardless of the number of candidates, the general assembly will hold an election.</p>	
<p>3.3.1 To be elected on the first ballot, the candidate must obtain the absolute majority of the votes of members present or represented by proxy, that is, all votes and abstentions will be counted.</p>	
<p>3.3.2 The candidate having 50% of the votes plus 1 will be elected.</p> <p>3.3.3 If there is no absolute majority, a second ballot will be held and candidates will be elected by simple majority, disregarding spoiled ballots and abstentions.</p>	
<p>3.3.4 In case of a tie, the decision will be referred to the board of directors.</p>	
<p>3.4 The specific responsibilities of the secretary and treasurer of the board are as follows:</p>	
<p>3.4.1 The secretary oversees all reports of board meetings.</p>	

<p>3.4.2 The treasurer oversees the financial management of CIFEJ. He/she is responsible for the preparation of the annual budget in conjunction with the executive director, and for all financial reports to the board and to the general assembly.</p>	
<p>IV. The executive committee 4.1 The executive committee is made up of the president of CIFEJ, the two vice-presidents, the secretary, the treasurer, the secretary-general and/or the executive director.</p>	<p>4.1 The executive committee is made up of the president of CIFEJ, the two vice-presidents, the secretary-general and/or the executive director. (To be deleted: the secretary, the treasurer) (Günther Kinstler)</p>
<p>4.2 Three voting members constitute the quorum of the executive committee.</p>	
<p>4.3 It may also call on representatives of the members to serve on any working committees, which might be proposed.</p>	
<p>V. Secretary-General 5.1 The responsibilities of the Secretary-general are the following:</p>	
<p>5.1.1 Supervises the functions of the secretariat's office, making sure that it applies the decisions taken and approved by the board of directors and/or the executive committee;</p>	<p>5.1.1 (To be added :) To administer the operating budget, to supervise the functions of the secretariat making sure that it applies the decisions taken and approved by the board of directors and/or the executive committee; (Mohsen Chiniforoushan)</p>
<p>5.1.2 To second the directors in any of their tasks;</p>	
<p>5.1.3 To be certain that CIFEJ is operating within the law of the host country;</p>	
<p>5.1.4 To ascertain that CIFEJ benefits from any programs in the host country which might give financial support to CIFEJ: grants, gifts, sponsorships, etc.;</p>	
<p>5.1.5 To suggest any new policies which might be appropriate for CIFEJ and which is made possible because of the opportunities in the host country.</p>	

5.1.6 The secretary-general may assist the treasurer in his tasks.	
5.2 The responsibilities of the executive director are the following:
